**PETITION INSTRUCTIONS**

The South Central Province Undergraduate Chapter of the Year Award is the highest Province award available to undergraduate chapters for outstanding achievement. The undergraduate chapters nominated must have at least seven (7) members who are financial with the Undergraduate Chapter, Province, and Grand Chapter of Kappa Alpha Psi Fraternity, Inc. at the date of its submission. The Achievement Committee will select no more than one chapter in each category: small 7-20 members; medium 21-30 members; and large 31 members or more.

Petitions for the Undergraduate Chapter of the Year Award must be typed and submitted on a standard form secured from the South Central Province. The completed form must be submitted to the Province Keeper of Records and Province Keeper of Exchequer no later than the end of the first business session of the Province Council meeting. Consideration will be given only for activities occurring from Province Council to Province Council.

The completed application form must be supported with documentation. The documentation may include official letters, printed programs, brochures, newspaper articles, and photographs (none of which will be returned).

The petition is divided into five (5) parts:

**Part I** – Background is general information that provides basic background information about the chapter.

**Part II** – College/University Certification certifies that the chapter and the undergraduates are in good standing with the institution. This section must be completed and signed by an official (e.g., Dean of Students or their designee) of the college or university. Transcript with the official seal must be included.

**Part III** – Province Certification certifies that the Chapter is in good standing with the South Central Province. This section must be signed by the Province Keeper of Records and Province Keeper of Exchequer.

**Part IV** – Written endorsement of the Chapter Advisor.

**Part V** – Areas of Achievement indicates the areas for which the Chapter's outstanding achievement will be considered. Convincing statements should be made to support the various areas.

The areas to be judged are listed below. Each area will be awarded points as indicated on the form. Applications should show the extent to which:

1. Chapter goals and objectives are developed and are a regular part of the chapter's management planning (10 Points);
2. The chapter's budget is consistent with the goals and objectives (5 Points);
3. An effective and viable chapter Guide Right Program is ongoing (10 Points);
4. An effective chapter intake program (5 Points);
5. National and Province programs for Kappa Alpha Psi are supported as an ongoing part of the Chapter's activities (5 Points);
6. Extra meritorious service to the campus community and external civic community occurs (10 Points);
7. There is involvement in campus leadership and academic achievement of members (10 Points);
8. Chapter members hold appointive and/or elective positions within the Province or at the Grand Chapter level (5 Points);
9. Sponsors a Student of the Year candidate at current meeting (20 Points);
10. Overall grade point average for the preceding three (3) semesters (20 Points).

**PETITION INSTRUCTIONS**

The South Central Province Undergraduate Brother of the Year Award is the highest Province award available to an undergraduate member. The completed application form must be supported with documentation. It is important that the petition be accurate, factual, and concise and convincingly supported by exhibits. Exhibits may consist of copies of newspaper articles, copies of certificates and awards, letters of acknowledgement, photographs, etc. The petition must be typewritten and the candidate's achievements summarized in no more than three (3) pages.

Petitions for the Undergraduate Brother of the Year Award are submitted on a standard form secured from the South Central Province. The completed form must be submitted to the Province Keeper of Records and Province Keeper of Exchequer no later than the end of the first business session of the Province Council meeting.

The petition is divided into seven (7) parts:

**Part I** – Background is general information that provides basic background information.

**Part II** – Local Chapter Certification certifies that the candidate is in good standing with the local chapter. This section must be completed and signed by the Chapter Polemarch, Keeper of Records, and Keeper of Exchequer.

**Part III** – Province Certification certifies that the candidate is in good standing with the South Central Province. This section must be signed by the Province Keeper of Records and Province Keeper of Exchequer.

**Part IV** – College/University Certification certifies that the undergraduate is in good standing with the college or university and is working toward a degree. This section must be completed and signed by an official (e.g., Dean of Students or their designee) of the college or university. A copy of the official transcript with the official seal must be included.

**Part V** – Character References provides for entering the names and addresses of three (3) individuals who are submitting letters of recommendations attesting to the character and reputation of the candidate, one of which must be from the Chapter Advisor. These letters are an integral part of the petition and should be written by individuals who are thoroughly familiar with the candidate. The letters should be addressed to the Province Polemarch and must be attached to the petition.

**Part VI** – Summary of Candidate’s Achievement. Convincing statements should be made to support the various area(s).

The supporting statements should not exceed three (3) typewritten, single-spaced pages and should be attached to the petition.

**Part VII** – Other Contributions provides for entering any contributions other than regular dues and assessments made by the candidate to a province, undergraduate or alumni chapter, either monetary or as a personal performance in the Fraternity’s interest, in addition to any activity constituting the primary basis for this petition.

- Community Involvement (20 Points)
- Honors, Awards, and Scholarship (20 Points)
- College/University Involvement (20 Points)

The candidate nominated for this award must be matriculating for an undergraduate degree. The candidate's grade point average must be 3.00 or higher on a 4.0 scale. It is important that the typed petition be factual and concise.

Petitions for the South Central Province Scholars Award are to be submitted on a standard form secured from the South Central Province. The completed form must be submitted to the Province Keeper of Records and Province Keeper of Exchequer no later than the end of the first business session of the Province Council meeting.

The petition is divided into six (6) parts:

**Part I** – Background Section contains some basic information about the nominee.

**Part II** – Local Chapter Certification certifies that the candidate is in good standing with the undergraduate chapter. This section must be signed by the Chapter Polemarch, the Keeper of Records, Keeper of Exchequer, and the Chapter Advisor.

**Part III** – Province Certification certifies that the candidate is in good standing with the South Central Province. This section must be signed by the Province Keeper of Records and Province Keeper of Exchequer.

The petition is divided into three (3) parts:

**Part I** – Background is general information that provides basic background information about the Chapter.

**Part II** – Province Certification certifies that the Chapter is in good standing with the South Central Province and Grand Chapter. This section must be signed by the Province Keeper of Records and Province Keeper of Exchequer.

**Part III** – Areas of Achievement indicates the areas for which the Chapter's outstanding achievement will be judged. Convincing statements should be made to support the Chapter's achievements.

Each area will be awarded points in the following areas. Submissions should show the extent to which:

1. Chapter goals and objectives are developed and are a regular part of the chapter's management planning (10 Points);
2. The Chapter's budget is consistent with the Chapter's goals and objectives (5 Points);
3. An effective and viable Chapter Guide Right Program is ongoing (15 Points);
4. The Chapter provides planned and well articulated support to undergraduate chapters (15 Points);
